As your newly- elected Vice-Minister, I am happy to also assume the responsibility of JPIC Animator for our LaVerna Region. Justice, Peace and Integrity of Creation (JPIC), encompasses

family, work, ecology, peace and justice, and encourages the living of our Rule as related to the apostolic activities from the point of view of who we are, Secular Franciscans.

In the Beatitudes, Jesus declares that those are blessed who hunger and thirst for justice (Mt 5:6). Equally blessed are the peacemakers (Mt 5:9). Jesus also indicates what is important in Christian life: “Seek first the Kingdom of God, and His righteousness” (Mt 6:33). Jesus Himself sought first the Kingdom of God and His justice, and showed hunger and thirst for justice and was persecuted because of it. He Himself is the source, the giver and the cause of peace. As Franciscans we are called like St. Francis to rebuild the Church—restoring it to a place that is just and reconciled.

In reviewing our fraternity Annual Reports over the last two years, I’ve found that we continue our mission of bringing Gospel to Life and Life to Gospel. COVID limited some activities for sure, but many fraternities have found ways of continuing help to the less fortunate, ways to promote pro-life issues and ways to care for the environment. Following are a few of the activities our fraternities are continuing our charism.

One fraternity’s Compassion group continues to minister to those less fortunate with electric bills, past due rent payments, clothing for children and food by working closely with Caritas who ministers in their area. Another fraternity runs and hosts a Sobriety Café, an outreach program for recovering addicts.

Our fraternities have continued to donate hygiene products to local shelters, to work at food pantries and prepare dinner boxes for distribution for the less fortunate.



Some fraternities Walk-for-Life, visit the sick and the homebound. In addition, fraternities financially support poor families in India via Franciscan Family Apostolate; they read and discuss encyclicals such as *Laudato Si* and *Fratelli Tutti* by Pope Francis.

It’s amazing to see the Holy Spirit working in our local fraternities. Let us continue our mission of reaching out to others and caring for our environment.

It is my hope to invite representatives from our fraternities to give us a deeper insight into their apostolic works at a future La Verna Region District Gatherings.

## The Family Of Jesus, A Path To Follow

Dear Brothers and Sisters,

There are many realities the Church teaches us today based on the reflections of Pope Francis. We should note that we are not going to address all the challenges of the current family here but we will stop to contemplate some aspects of it considering the experience of the Family of Nazareth. In this very special year dedicated to Saint Joseph we want to share the tenderness and love of the Family of Nazareth.

In the last fifty years, families have undergone a drastic transformation. In many places, large numbers of marriages end in divorce. Free union [cohabitation] is increasingly common and more and more children are born to unmarried couples. Adoption and parenting by same-sex couples is becoming increasingly normal. Faced with this reality, as a starting point, we can speak in fraternity about the following questions.

1. What factors are triggering these changes in the family structure?

2. How does communication take place in our families? What are we communicating?

Judge

From our Christian worldview we are called to look at this situation with serenity and work for the vitality of our families. Problems, difficulties, times of crisis can befall us but our faith and our values invite us to look further. We share the reflection of Pope Francis, who proposes the Family of Nazareth to us as the model towards which we are called and should always return. The Pope told us: The liturgy invites us to contemplate the Holy Family of Jesus, Mary and Joseph.

Second Point

The evil one makes us see and condemn our frailty, whereas the Spirit brings it to light with tender love. Tenderness is the best way to touch the frailty within us.

Joseph saw Jesus grow daily “in wisdom and in years and in divine and human favor” (Lk 2:52). As the Lord had done with Israel, so Joseph did with Jesus: he taught him to walk, taking him by the hand; he was for him like a father who raises an infant to his cheeks, bending down to him and feeding him (cf. Hos 11:3-4).

In Joseph, Jesus saw the tender love of God: “As a father has compassion for his children, so the Lord has compassion for those who fear him” (Ps 103:13). In the synagogue, during the praying of the Psalms, Joseph would surely have heard again and again that the God of Israel is a God of tender love,[11] who is good to all, whose “compassion is over all that he has made” (Ps 145:9).

### Third Point

Gospel passage invites families to welcome the light of hope that comes from the home of Nazareth, in which Jesus’ childhood unfolded in joy. Jesus, says St Luke, “increased in wisdom and in stature, and in favor with God and man” (2:52). The nuclear family of Jesus, Mary and Joseph is for each

believer and especially for families an authentic school of the Gospel. Here we admire the fulfilment of the divine plan to make the family a special community of life and love. Here we learn that every Christian nuclear family is called to be a “domestic church”, to make the Gospel virtues shine and become a leaven of good in society. The classic traits of the Holy Family are: reflection and prayer, mutual understanding and respect, and a spirit of sacrifice, work and solidarity.



### Act

Consider sharing responses with your family or fraternity on the following questions: a. What values does Pope Francis invite us to incorporate and keep working on in our families? b. What could we do as a fraternity to support and accompany families in our community?

and defend us from all evil. Amen



## What does Franciscan charism have to offer to a world of chaos and complexity?

Speaker, theologian, and author, Sr. Ilia Delio, OSF shares her thoughtful insights on the life of St. Francis and why contemplation is necessary to follow his path in the 21st century. In her Youtube link titled *Franciscan Spirituality*, Sr. Delio speaks briefly on the spiritual perspectives of St. Francis, John Duns Scotus, St. Bonaventure, and Teilhard de Chardin. For example, Sr. Delio explains why Teilhard de Chardin said that the physical energy of the universe is motivated by love, and that the whole universe is orientated toward the fullness of Christ.

Sr. Delio is a Franciscan Sister of Washington, DC and holds the Josephine C. Connelly Endowed Chair in Theology at Villanova University. She is the recipient of a Templeton Course in Science and Religion award and author of many books including *The Unbearable Wholeness of Being*, which

won the 2014 Silver Nautilus Awards and a Catholic Press Association Book Award. She has presented talks at Cardinal Stritch University in Milwaukee and as keynote speaker at the OFS National Quinntinnet meeting held in Skokie, IL.

One of my first memories of working on the La Verna Regional level was with the then REC Formation Director Jean Platz, OFS. Jean served for many years, and along with Lester Bach, OFM Cap, put together the La Verna Regional Formation Manual in 2008.

I remember one meeting where Jean gave a dynamic formation presentation at a 2009 district gathering workshop on Holiness. During her talk, I was busy standing behind her scribing on the flip chart the participants call out words which reflected HOLINESS. Here are some of the words I managed to copy down on paper: *relationship, prayerful,*

*companion, kind, patient, like God, simple, love, humble, forgiving.* This spontaneous "word splash" from the group still holds true about HOLINESS.

The group's word splash may be summed up as **"dynamic,"** which is akin to **holiness,** in that *dynamic* is the action and motivation of holiness that is felt, seen, and alive. Franciscan formation is about "dynamic" formation as the REC Vision Statement proclaims.

Dynamics becomes an important part of our path in our 2021 OFS "journey of renewal" and beyond. As Fr. Frank Corradi, OFS, our newly-appointed REC Formation Director, steps into the role, our Vision does not change. Fr. Frank is also a member of St. Elizabeth of Hungary Fraternity located in Chippewa Falls.

**Our mission and ministry, that is our Franciscan path and work ahead will change and adapt for changing times, but our Rule adapts us to life's changing times.**

This year as we celebrate the 800th year Anniversary of our OFS Rule 1221 to 2021, let us be more dynamic than ever in keeping the Vision of meaningful growth in Franciscan LIFE.



"Dynamic " conversion that is energetic, an "being" in motion, effective action. It even has a musical quality about it – a music connotation of changing variation in sounds – soft, loud, increasing or decreasing volume, and many more variations to put the language of love in our emotions. A definition for dynamic is also – "humble and creative."

St. Francis, in his Canticle to Creation was truly dynamic in his Italian poem to creation...a prophet of ecology observing & honoring the wisdom of the earth, respecting all things in nature and in humanity.

Formation is composed of lesson plans with essential elements and Franciscan characteristics. But to make it come **alive and dynamic!** There is structure to formation, this is true. And, yes, to make it come alive creatively with "prophetic creativity" for moving hearts for wonder and love, bringing others to discern and conversion, this is the heart and soul of formation. Dynamic formation is a process of developing and evolving into the "Christ light."

Pope Francis encourages us to "be creative about the future" and, as we apply prophetic creativity as noted by our OFS National Minister Jan Parker, ... *"we would grow closer to God and to each other. We would engage more deeply in our vocation. We would experience a more intense commitment with unconditional participation."*

This is what "dynamic formation" looks like, feels like, tastes like and is like! Profound spirituality and joyful vocation are an outcome, a by-product of the Pentecost of Being in dynamic formation.

Recall the shout words describing Holiness the 2009 district gathering during Jean's presentation, the oneness with those participant's presence, the movement of the Spirit in their hearts as they named their lived experience; we shared our witnessing of holiness. That witnessing of the Spirit keeps me forming in the Franciscan way of life.

Now it is time for me to hand off the mission and ministry to Fr. Frank but not the Vision. The Vision belongs to all of us. I am looking forward to the next chapters of my Franciscan way and together our call to Holiness!

Please welcome Fr. Frank Corradi with that "dynamic" Franciscan spirit of hospitality and holiness! Peace and all good.


